

GolfWise — Terms of Service

Version 1.0 — April 2026

1. Who We Are

These Terms are provided by **Ed Solutions Ltd** (“we”, “us”, “our”).
We operate the **GolfWise** platform (“GolfWise”).

GolfWise is a digital platform that provides software, data, and interactive services for golf and related activities. GolfWise may include tools for recording rounds, analysing performance, planning golf experiences, connecting with other golfers, and accessing golf-related information. The features and functionality of GolfWise may change or expand over time.

By creating an account or using GolfWise, you agree to these Terms. If you do not accept them, please stop using GolfWise.

These Terms are governed by New Zealand law.

2. Eligibility

GolfWise is for personal use.

If you are under 16, a parent or guardian must approve your use and is responsible for your activity.

We may refuse or suspend access if eligibility requirements are not met.

3. Your Account

You must provide accurate information and keep your login details secure.

You are responsible for all actions under your account.

We may suspend or terminate accounts that misuse GolfWise or breach these Terms.

4. Your Content

You may upload or enter information such as scores, notes, or photos (“Your Content”). You retain ownership of Your Content. You grant us a licence to store it, display it, and use it as needed to operate GolfWise.

You must only upload content you have rights to use. We may remove content that is harmful, unlawful, or infringes others’ rights.

5. GolfWise Content

All branding, design, text, graphics, and software belong to Ed Solutions Ltd or our licensors.

You may use GolfWise for personal, non-commercial purposes only.

You must not copy, scrape, or reuse GolfWise content or data without written permission.

6. Acceptable Use

You agree not to:

- attempt to access data that isn't yours
- upload harmful, offensive, or misleading material
- interfere with GolfWise's operation
- use GolfWise for unlawful or abusive behaviour

You must not use GolfWise in any way that breaches New Zealand's **Harmful Digital Communications Act 2015**. This includes posting or sharing content that is abusive, threatening, harassing, or intended to cause serious emotional harm.

We may report serious or unlawful behaviour to **Netsafe** or the **New Zealand Police** if we believe it breaches the Harmful Digital Communications Act 2015 or poses a risk to others.

We may restrict or remove access if these rules are broken.

7. Premium Features and Payments

Some features require a paid subscription.

Payments are processed securely through third-party providers such as Stripe or app stores.

Renewals, cancellations, and refunds follow the policies of the platform you purchased through.

If your subscription ends, premium features will no longer be available.

8. Availability

We aim to keep GolfWise reliable, but we cannot guarantee uninterrupted access or perfect accuracy of course information, statistics, or user-submitted data.

We may suspend access for maintenance, security, or operational reasons.

9. Liability

To the extent permitted by New Zealand law, Ed Solutions Ltd is not liable for any loss, damage, or data breach arising from your use of GolfWise.

Nothing in these Terms limits rights that cannot be excluded under the **Consumer Guarantees Act 1993**.

If any part of these Terms is found invalid, the remainder continues in effect.
